All requested information must be completed in it's entirety. All information in this document is strictly confidential and will not be shared with outside parties.

Tuition of Fall 2011 enrollment is as follows (September thru June):

- Full Time: \$8,500.00(9,000.00-2 year olds)**
- Part time (3 full days/week) \$8,000.00(\$8,500.00-2 year olds)**
- Part time (5 half days/week)\$7800.00 (\$8,300.00-2 year olds)**

Tuition for Summer 2012 (July through August)

- Full Time \$1,650.00 (\$1,750.-2 year olds)**
- Part-time (3 full days/week) \$1,550.(\$1,650-2 year olds)**
- Part time (5 half days/week) \$1,510.(\$1,610.-2 year olds)**

If the above named child is enrolled during periods other than the term beginning Summer or Fall, the entire amount of tuition due will be prorated, and assessed as follows:

I, we realize that the \$25 per month potty training fee (if applicable) will discontinue only after I notify administration, and the teaching staff agrees that my child is fully trained.

I, we realize that we are expected to participate in school fund raisers twice per year in the Fall and in the Spring. A minimum profit of \$150.00 per year fund raiser is required. If I do not wish to actively participate I am responsible to donate \$150.00 per fund raiser. I/we realize that the Academy operates approximately 50 weeks out of the year excluding holidays. Tuition is assessed annually, however payment options of monthly or twice monthly are available. There is no per diem tuition. Tuition is determined by the annual cost of care factor divided by 12 months to cover 50 weeks of operating expenses. Tuition is ongoing as contracted regardless of illness, vacation or holidays.

Tuition will be paid by check or money order. Since tuition covers operational expenses, it is imperative that tuition be paid on time according to the Tuition Agreement Schedule.

This Contract is legally binding for the period contracted for. I give Creative Mansion Children’s Academy, Inc., authority to assign my wages if upon leaving the school an unpaid balance remains on my tuition account.
